## FACT SHEET

- ♥ Congenital heart defects are the most common birth defect in United States, affecting approximately 1 in every 111 babies.
- ♥ As many as 1.3 million Americans alive today have congenital heart disease.
- ♥ Nearly twice as many children die from congenital heart defects in the U.S. than from all forms of childhood cancer combined.
- ♥ Cardiovascular disease is the second leading cause of death for children age 15 and younger, and congenital heart defects alone claim about 3,600 lives per year.
