<p><b><u>Family Planning (FP)</u></b></p> <p>Family Planning provides services to women and men of reproductive age. Services offered include:</p> <ul style="list-style-type: none"> <li>Annual exams</li> <li>Breast exams</li> <li>Diagnosis and treatment of STDs</li> <li>FDA approved birth control</li> <li>Pregnancy testing</li> <li>HIV testing</li> </ul> <p>Counseling, education, and referrals</p> <p>Confidential services are provided on a sliding scale fee.</p> <p><b><u>Healthy Families (HF)</u></b></p> <p>Healthy Families offers services to parents expecting a child and families with a baby younger than three months old, who live in Dubois, Gibson, Pike, Spencer, or Warrick Counties.</p> <p>Services offered include support, information, and referrals in:</p> <ul style="list-style-type: none"> <li>Child development</li> <li>Prenatal care</li> <li>Education</li> <li>Goal setting</li> <li>Employment</li> </ul>	<p><b><u>Energy Assistance Program (EAP)</u></b></p> <p>The Energy Assistance Program provides financial assistance to low income households (income guidelines) to maintain utility services during the winter heating season.</p> <p><b><u>Individual Development Accounts (IDA)</u></b></p> <p>The IDA program assists low to moderate income Hoosiers attain their goals through matched savings incentives and financial education. Qualified participants set savings goals and make regular deposits. Every \$1.00 dollar you save is matched at a rate of \$3.00 to help you reach your goals.</p> <p><b><u>Affordable Senior and Family Housing</u></b></p> <p>In Huntingburg, Indiana, Stork Place Apartments provide 17 affordable senior housing units and Wagon Works Apartments provide 56 affordable housing units. Additionally, five single family homes have been renovated and provide affordable family housing.</p>	<p><b><u>Weatherization Assistance Program (WX)</u></b></p> <p>The Weatherization Assistance Program provides energy conservation measures to reduce the utility bills of low income Hoosiers. The program offers clients a permanent solution to reducing their energy bills by making their homes more energy efficient.</p> <p><b><u>Home Safety and Comfort</u></b></p> <p>TRI-CAP's trained staff provides the following services at reasonable prices to people of all income levels:</p> <ul style="list-style-type: none"> <li>Home Energy Audits</li> <li>Air Leakage Testing</li> <li>Air Sealing</li> <li>Insulation</li> <li>Lead Risk Assessments</li> <li>Combustion Safety Testing</li> <li>Moisture Problem Identification</li> <li>Energy Consulting</li> </ul>	<p><b><u>Head Start Services (HS)</u></b></p> <p>Head Start is a comprehensive child development program for low-income preschool children age three to five. Children with special needs are also served.</p> <p>Individualized services are provided in the areas of early childhood education and development; medical, dental, and mental health, nutrition, and parent involvement.</p> <p><b><u>Private Preschool</u></b></p> <p>Afternoon preschool services are offered to Head Start families with children three to five years of age.</p> <p>Children must be three by August 1st.</p> <p>A weekly fee is charged and child care vouchers are accepted.</p> <p>Classes are offered after the Head Start classes are finished for the day.</p>						
<p><b><u>Retired &amp; Senior Volunteer Program (RSVP)</u></b></p> <p>The Retired &amp; Senior Volunteer Program is a network for people 55 and over who want to give back to their communities through rewarding and significant service activities. Benefits and recognition are offered.</p> <p><b><u>Healthcare Resource Navigator</u></b></p> <p>Free, unbiased services from a certified resource navigator to anyone needing education or assistance in signing up for health insurance.</p> <p><b><u>Dubois County CARES</u></b></p> <p>TRI-CAP is the fiscal agent for the Dubois County Coalition for Adolescent Resilience and Empowerment Strategies (CARES), a coalition that supports a sustainable alcohol and drug-free culture for youth in Dubois County.
