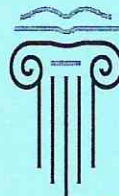
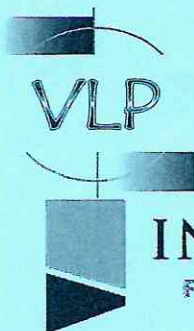

Indiana Legal Services (Statewide Assistance)

Indiana Legal Services provides representation and advice in domestic violence, consumer law, senior law, housing, public benefits, and other civil legal aid matters. Intakes for assistance are taken weekdays by telephone only from 9:00 a.m. to 1:00 p.m. (Central). You can also apply on-line.

Legal Aid Society of Evansville (Vanderburgh County Only)
